

The Master's Thoughts

Back in April 2022, I attended a Grand Lodge leadership retreat where many Masonic leaders from throughout California, as well as some Grand Lodge officers, were quite surprised that Table Mountain Masonic Lodge still existed after the Camp fire. Some of them appeared amused by our insistence that we were growing our lodge even after such a devastating event. Well, we have not only survived, we are now known throughout California as an innovative and fast growing lodge. Because of this, Masons from other lodges have asked if we are doing anything differently. I reply, "yes, we are doing everything differently".

Inertia, defined as a tendency to do nothing or to remain unchanged, is the enemy of every organization, and it is certainly a killer of Masonic lodges. When a lodge is overcome with inertia, the morale of the membership decreases, boredom becomes the norm, participation then decreases, activities become fewer, and new members quickly lose interest. Actions counters inertia, but change, in the form of innovation can utterly defeat inertia. It requires a new organizational culture that nurtures new ideas and new ways of doing everything. At Table Mountain Masonic lodge # 124 we have overcome inertia by jettisoning the boring, and embracing new ideas and opportunities. To get the special rate you must call 530-762-6051 and ask for the Masonic event rate.

Event Schedule – Saturday Sept 16

3 pm - Social Gathering at Table Mountain Masonic lodge. (see map: <u>from Chico</u>, or <u>from Oroville</u>)

4:30 to 6 pm - Dinner available to attendees at Table Mountain Masonic Lodge (see map). The dinner will be barbecued meats and accompaniments, and will be served by DeMolay. Cost is \$15.

6:30 pm - Degree begins. Please be at event location by this time. Travel to the location from the Table Mountain lodge takes approximately 30 minutes. The road is paved most of the way, then gravel for a short distance. (see map and driving instructions from Table Mountain Lodge to the event location). There will also be signs posted on the route. The 3rd degree will be presented by the Scottish Rite / Shrine Past Masters degree team. Since this is an outdoor evening event in a remote location, we recommend that you dress comfortably, wear appropriate footwear and bring a jacket. It is a very short walk from the parking area to the outdoor lodge.

May 6, 2023 – Stated Meeting

At 1 pm, just prior to our Saturday May 6 stated meeting, the brothers and guests met for a fabulous homemade Mexican themed lunch provided and prepared by Bother Cole Hamilton and his very supportive wife Lisa. Everyone raved about the food. There was great attendance and as normal for our lodge there was lively conversation and lots of good humor. march, for the opening of the Holy Book and the national anthem prior to the pledge of allegiance. The additional music was exceptionally well received.

Our Secretary Brian Grandfield (PM) read the minutes of the previous meeting. Our Treasurer, brother Rich Gingery was not present, but had previously reported that the account total remained significant. However, the IRA gift that the lodge is to receive has not yet arrived from the investment firm.

Assured that sufficient funds were on hand Our Secretary Brian Grandfield (PM) presented the bills to be paid. All bills were paid. There was one new petition, and no pending reports of investigation.

Our Chaplain Brother Bob McElroy reported on those brothers and families that were ill, and those that were sent get well and thinking of you cards. Brother Bob also read the Sacred Scroll for our recently departed brother Tom Vandergrift, and then lead the brothers in 60 seconds of silence while Taps was played. The brothers were then reminded of the Masonic graveside memorial for brother Stan Englebrite, on June 23, Thursday, 11 am, Manzanita Cemetery, Manzanita Road Lincoln, California. Also, the brothers were reminded that there will be a Masonic memorial in our lodge for brother Tom Vandegrift, in our lodge, but that the date has not yet been determined (*Now schedule for June 17, see calendar*).

The Master then took the opportunity to thank, by name, each of the brothers for specific contributions to work, progress and appearance of our lodge. Specifically recognized were

bothers Brian Grandfield (PM), Bob McElroy, Rich Gingery, Juston Purcell (PM), Caleb Chinn (PM), Frank Beard, Phil Howard, Oso Harju, Cole Hamilton, Steve Kane, Matt Sutter, Glenn Story (PM) and Woody Nelson (PM).

Then the status of each current Entered Apprentice's progress on their proficiency was discussed, and each coach reported on their progress and their efforts to facilitate the process. The brethren discussed and eventually proceeded with the 2nd degree conferral change to Thursday May 25 at 6 pm. The proposed positions for that conferral were reviewed, and thus confirmed. It was agreed that we would continue planning for our next lodge social event.


The brothers were then reminded that at our June stated meeting they would vote to finalize the 2024 dues increase. It was also noted that all brothers have been notified of the pending 2024 increase in dues, by at least two communications means. Also, that all but one lodge member seems to understand the reality of inflation and the financial challenges of running a lodge.

The lodge then proceeded to read the names of those members being suspended for significantly delinquent dues and who have failed to respond to our outreach efforts. After discussion, the suspensions process was completed. Additionally, two members that are no longer living in our region were granted demits. The brethren were also informed that remits for those brothers eligible were being submitted. Also, that the total process of suspensions, demits and remits should save the lodge over \$2300 in fees to Grand Lodge.

The Worshipful Master reminded the brothers that in two days there would be the May 8 Public Schools Employee and Student of the Year Award Ceremony in the downstairs lodge room. Preparations and arrangements for the event, food and refreshments, and the accompanying upstairs lodge open house were reviewed and finalized.

Due to time constraints, there were no other reports from committees. They will be presented at the June stated meeting. The calendar of events for the next 3 months was briefly reviewed, and there was also a brief discussion of other important events scheduled for later in the year.

Brother Steve Kane volunteered to provide our June stated meeting lunch, and Brother Frank Beard volunteered to provide our July stated meeting lunch. There being no further business, the lodge was then ritually closed in short form, brotherly love prevailing.





















Masonic Youth Activity



Questions about Freemasonry that you might be asked: With answers

Is Freemasonry a religion?

No. Freemasonry is fraternity of religious men of many denominations and faiths. However, Freemasonry is <u>not</u> a religion, does <u>not</u> function as a church, and is in fact supportive of its members' own religious development, whatever religion or church they belong to. Freemasonry does <u>not</u> claim to be a replacement for religion. While each Masonic meeting is opened and closed with thanks to God, there are no worship services, no worship rituals, no wedding or baptismal rituals and no Masonic clergy. Freemasonry does <u>not</u> have its own holy scriptures and does <u>not</u> have a separate theological doctrine. No Freemason is required to jettison his own religion's doctrine to become a Freemason.

What is the philosophy or the teachings of Freemasonry?

While not a comprehensive short list, the following represent the foundations of Freemasonry: Faith and trust in God (by whatever name or term you wish to use to describe him). Brotherly love, relief, and truth. The virtues of Temperance, Fortitude, Prudence, Justice, Faith, Hope and Charity. Knowledge and respect of the Seven Liberal Arts and Sciences (Grammar, Rhetoric, Logic, Math, Geometry, Music and Astronomy). Knowledge and understanding of your Holy book (whatever it may be). Fidelity and Honor, and that a man has a responsibility to behave honorably in everything he does. Support for a quality public education. Care of the widows and orphans, public service, continuous intellectual growth and lifelong self-improvement, patriotism, good citizenship and the God given right of humans to be self-determining.

Are there differences between Masonic lodges?


While there is a common philosophical thread within all regular Freemasonry around the world, there are differences in ceremonies, content and practices. Within the English speaking nations, the forms of Freemasonry are primarily derived from the Scottish/English model. Within the U.S., from state to state, there are mostly small differences in the ceremonies and practices. However, a Freemason from one nation or state is entirely welcome in a lodge anywhere. There are also some local cultural differences between lodges that reflect the uniqueness of their community and their circumstances. The demographics of a lodge will generally reflect the community where they are located. Some lodges are rather casual in dress, and in other lodges there is an informal dress code that encourages business dress. Additionally, the activities of any particular lodge reflects the interests of the members, the needs of the community and the resources available.

Masonic Formation

Logic and individuality are foundations of Freemasonry

Logic is one the seven liberal arts and science emphasized in our Masonic education, and specifically addressed in the 2nd degree. There is a surprising variety of definitions of logic. However, the one I prefer is "reasoning in accordance with strict principles of validity". There is such a thing as invalid logic or false logic, but in this essay the word *logic* refers to reasoning in accordance with valid principles.

Logic is a scientific principle, aligns with all aspects of mathematics, and it is the foundation of all legitimate scientific research. The absence of a clear and valid logical thread of reasoning running unbroken from beginning to end renders invalid



any research findings. Logic is also one the foundations of Freemasonry.

Being logical requires a person to put their *passions and emotions within due bounds*, to set aside their biases and preconceived notions, and to focus on the obtainment of truth, whatever that may be. To be logical, we must be knowledgeable of the world around us. We therefore must be aware of and fully use our *five senses*, which are also addressed in the second degree. Being logical requires the *basic skill of math*. Being logical, is made easier by practicing the virtues of *fortitude*, *prudence*, *temperance and justice*. *Rhetoric* based on logic is the most honest, most long lasting and effective from of persuasion with intelligent, knowledgeable and sane people.


The ancient Greek philosophers are generally credited with the first written explanations of logic. However, logic existed and was practiced long before the philosophers put a name to it. Consider the ancient builders, our inspiration. Their profession was by necessity based on logic. A building, a beam, or stone is straight, square, level or plumb, or it is not. No amount of wishing, emotions, confused rationalization can make something straight, square, level or plume. Accuracy in measurement was the key. Measurement could not be replaced by guessing or wishing. Lengths, angles and curves had to be calculated and measured. Amounts of materials, transportation, time and workers had to be calculated. Basic math was a necessary. The symmetry of beauty requires mathematical symmetry. The proper use of tools was necessary for effective outcomes so people had to be taught, and logical step by step instruction is the best form of teaching.

Effective construction outcomes required the Mason to have an ability to think through and visualize the entire process, and the desired outcomes. The construction process was logical, conducted in steps, with the validity of the construction work checked and measured by the Masters. What was right and wrong was clearly defined. Each step and level of the work was the foundation for the next step or level. The failure to have and follow a logical thread of thought resulted in delay or flawed construction that would not stand the test of time. The ancient crafts were by necessity, logic based. So are today's crafts and trades reality and logic based professions.

The free stone operative Masons of antiquity had, by necessity, to cooperate with other Masons and artisans to complete the structure. However, their individual work, their craft, was their responsibility. They measured, chipped, smoothed and polished the stones by themselves. They controlled their own individual pieces of work, they took responsibility for the quality of their work, and they judged when their work was ready for the Master's evaluation. They respected each Mason's responsibility for their work, and they respected the challenges inherent in every artisan's craft. They also respected the skills of each master artisan, regardless of their religion, nationality or language. This too has always been the essence of American individualism. Respect for self as a responsible individual, respect for the independence of others, and judging people only by their character and accomplishments.

There was a time when logic was emphasized and taught as part of proper education. I see little evidence of that today, even at the highest levels of schooling. Instead, in schools and within academia there is growing emphasis on reasoning by intuition, emotions, and slogans. The result is not true reasoning, but instead the rationalization of biases, ignoble desires and even hate. Some academics have even argued that logic and the resulting rational thinking is not necessary, too hard to teach, and even counterproductive to the evolution into what they call as social justice based society. However, I have observed that their long winded arguments are always confused because they lack a clear logical thread, and are instead mere rationalizations of the authors own inability to function logically.

In the graphic on the right, the person on the left (red background) is represented as having a clear logical thread of thinking, that which constitutes valid reasoning. The person on the right (blue background) is represented as randomly searching for some point or claim, that he can use to rationalize his belief or argument.



(please note that nothing political is implied by the left or right positioning, or the red and blue colors).

Today there appears to be a concerted effort among some pundits and so called educators to dismiss any trace of individuality, and instead glorify the idea that individuals should submit themselves to opinions of others and decisions of groups, even when they are ill-informed and obviously illogical.

Many researchers have noted that *stupidity* is the condition resulting from the failure to logically reason. The famed German theologian Dietrich Bonhoeffer argued that it was not evil people who were the greatest danger to society, instead it was stupid (illogical) people. In Bonhoeffer's theory of stupidity there are two types of people: those who logically reason and those who don't. According to Bonhoeffer, the latter are dangerous. According to Bonhoeffer, people are stupid when they fail to think critically and evaluate information, and as a result they are often content to blindly follow destructive mass social movements. Stupid people are not necessarily evil, but they can be used by those who are. Teaching people to respect logic, learn logic and to reason logically is the best defense against stupidity.

Herd behavior is among the pre-eminent causes of stupidity. Numerous scientific studies have shown how individual humans can be swayed by the crowd to adopt positions which go against all logic. The honored American philosopher Eric Hoffer, in his classic book *The Passionate State of Mind*, described how the minds and lives of people have been damaged or destroyed by their submission to ignoble emotions and passions, and to listening to the siren call of mass movements with questionable moral purposes. Hoffer documented the strong effort required by individuals to reason logically, and resist falling prey to emotional and bias based appeals.

In what often seems like a more illogical, divided, confused, oppressive and dysfunctional world, Freemasonry is a key bastion of logic and individuality. Freemasonry and the Catholic Church.

It is the general practice of those of us involved in what we know to be regular or true Freemasonry, to ignore or dismiss the existence or relevance of irregular Continental masonry, which in its many variations are derived from Masonry in France after many social and political revolutions, and corruptions of Masonic principles. However, much of the arguments against Freemasonry that are still espoused by the hierarchy of the Catholic church and some other churches, are directed at the doctrine and conduct of Continental masonry.

Here in the US, regular Freemasons often chuckle at those people that make the ridiculous claims that we are somehow atheists, deists, anti-religion, or involved in politics. However, Continental masonry Grand Lodges, generally named Grand Orients, often take political positions and exert significant political influence. Often they do it out of the sight of the public, thus feeding the suspicions of many people and church leaders. Additionally, in the past they have often targeted the privileges or power of religious organizations. Some of the Continental Grand Orients still celebrate their past victories against the power of the state churches and still promulgate a message that is anti-clerical. Some of these Orients have even removed the requirement to believe in God. The loss of power, wealth and influence during the 19th and 20th century social and political revolutions of France, Spain, South American and Italy are remembered by the Catholic church's highest officials. They note with suspicion that many of the leaders of those events were masonic. Additionally, church leaders are naturally suspicious, as are Regular Freemasons, of any group of atheists, deists, and anti-religious fanatics. Thus, the outright hostility of churches toward Continental freemasonry could be understandable.

"Why" might you ask, "are regular Freemasons subjected to the same attacks when we are so different from Continental masonry?" The answer might surprise you. While there are regular Freemasons almost everywhere, Continental masonry predominates in some areas of Europe, Africa, the Caribbean and South America. This is a result of historical regional connections to the Catholic church. In those regions Continental masonry had a historical role in opposing church privileges in those places where the Catholic church's or another official state church's power and wealth were a result of their support of oppressive regimes and policies. As a result, to the Catholic church, Continental masonry is the most obvious and visible manifestation of Masonry. In developing their opinions and policies the Catholic church, has for the most part, recognized no differences between regular Freemasonry, and Continental masonry.

However, there was a time when it looked like the Vatican had adjusted to regular Freemasonry. After the Second Vatican Council (1963 – 1966) many changes were taking place within Catholicism. Starting in 1973 many Catholics around the world were informed that it was permissible for Catholics to become Masons. This began with the English-speaking Catholics and spread to much of the rest of the world. Catholic bishops and Vatican

However, seven years later, the same Catholic leaders suddenly announced that joining Freemasonry was still forbidden under pain of excommunication – and always had been. Today, relatively little is available about this historic event / period in history. Below is the story that we have pieced together.

In the early 1970's, work was underway on a significant revision to Catholic Canon Law. As a result of that and other efforts, there was a widespread anticipation that the Catholic church would soon change its teaching concerning Catholics and Freemasonry. In August 1971, the National Catholic News Service - the official news service of the U.S. bishops - issued a lengthy statement which predicted that the Catholic Church would soon modify its position on Freemasonry.

The headline was, "Catholic-Masonic Relations Enter Friendly New Era," the report included commentary from leading experts in Rome, including Fr. Jean Beyer, SJ – Dean of Faculty of

Canon Law at the Gregorian University in Rome and a consultor to the Vatican Commission for the Revision of the Code of Canon Law. The syndicated story ran in official Catholic diocesan newspapers throughout the nation.

Ban On Masonic Membership Flexible

Given the right conditions, the answer seems to be "yes," according to experts here.

But this does not mean the Vatican is preparing to announce formally the end of the 273-year-old ban on Catholics enrolling in their local Masonic lodge, said one Vatican observer.

There is unanimous agreement around the Vatican that such a papal decree would be too dramatic and final. And it would not necessarily mean that the Masons would then give up any of their secrecy, a major reason for the Church's ban in the first place.

The ban of excommunication was enacted by Pope Clement XII in 1738, was strongly reemphasized by seven other popes, and was written into current Church law.

Canon lawyers revising book five of the current 1917 code, which deals with "offenses and penalties," are adhering to the general principle of keeping to a minimum the number of automatic excommunications left on the books of the revised code.

"We see many groups of Masons who intend to remain rigorously and sincerely faithful to their original inspiration based on their landmarks. Perhaps the best-known expert in Rome on Masonry, Italian Jesuit Father Giovanni Caprile, speaking of extremely limited penalties envisioned for the new canon law code, observed:

Analyzing the excommunication placed on Catholics who join the Masons, Father Beyer said Masons should reveal themselves as believers in God and defenders of their government if they want Catholic members. According to him:

"Membership in such a lodge ... need not imply any penalty (for a Catholic). There can be no excommunication except when this membership leads to unfaithfulness to God or alienation from Christ ... any membership that does not lead to this cannot lead a Catholic to excommunication. Nothing prevents the (Catholic) freemason who finds himself in these conditions from receiving the sacraments."

Agreeing with many Vatican sources, Father Beyer said it was

"not probable" that the Church would come forth with a dramatic lifting of the excommunication. He pointed out that such a ban stood validly in its time as a bulwark against "deliberate and active sectarianism."

Rather, Father Beyer looks to the revision of the code as being a silent answer to the modern dilemma. The new canon law will be a unique opportunity for adopting an attitude that takes facts more into account. Where condemnation is not renewed, the prohibition to join Masonry will also be removed."

Father Caprile suggested that Masons themselves make an examination of conscience and return to
"their primary inspiration, ridding
themselves, where it might exist, of

Thus, Masonic lodges in each country can make a major contribution toward ending the feud by being less secret, by publicly stating where they stand on "religious indifferentism, naturalism and a possible threat to church and state"—the central reasons for the Church's long efforts to keep Catholics out of Masonry.

CHURCH BAN ON FREEMASONRY EXPECTED TO BE RELAXED (198)

LONDON (NC) -- Some relexation on the Church's ben on Freemasonry is expected to be issued by the Vatican before the end of the year, according to letters sent all priests in England and Wales by their bishops.

The letters explained that excommunication will be lifted from all Catholics who have become Masons.

It seems probable, the letters said, that each national bishops' conference will be left to decide whether Masons will have to resign membership in being received into the Church, and also whether requests from layment o join the Masons may be granted.

Two years later, in June 1973, *National Catholic News Service* again reported that Catholic Church officials were expecting and planning for a change in Catholic Church position on Freemasonry. The article, "Church ban on Freemasonry expected to be relaxed," explained that the Catholic Bishops of England and Wales had sent letters to all priests in their districts, saying that some "relaxation" in the ban on Freemasonry was expected soon. Additionally, the report said, "it seems probable that each national bishops' conference will be left to decide whether Masons will have to resign membership in being received into the Church, and also whether requests from laymen to join the Masons may be granted."

This news was widely printed in official diocesan newspapers throughout the English speaking world and continued to be discussed in newspapers and clerical journals between the summer of 1973 and spring 1974. The U.S. bishop's news service reported that the growing consensus was that the old prohibition against Freemasonry would soon be changed. This must have been very welcome news to the many Catholic Freemasons throughout the world.

On September 18, 1974, National Catholic News Service released a story with a startling headline: "CATHOLICS GIVEN QUALIFIED PERMISSION TO JOIN MASONS."

The article announced that Cardinal Franjo Šeper, prefect of the Congregation of the Doctrine of the Faith (Vatican), had sent a letter regarding Freemasonry to Cardinal John Krol, president of the U.S. Conference of Catholic Bishops. The American bishops released the full translation of the letter, along with commentary which emphasized that now "Catholic laymen may join Masonic lodges that do not plot against the Church."

The text of the cardinal's letter itself does not explicitly state that Catholics can be Masons. Instead, it states that Catholics are only forbidden from joining "associations which plot against the Church." But the U.S. bishops' commentary made it clear that they understood this to mean that Catholics could in fact join Masonic lodges in some cases - that the Masons were not intrinsically anti-Catholic.

Here we have what seemed like the first clear admission from Catholic church leaders in the English speaking world and from a high Vatican official, that our part of Freemasonry (regular Freemasons) were not anti-religious and not conspiring against the Catholic church. Here we see evidence of some common sense prevailing, and the hope of further understanding.

The full text of the Šeper's letter is as follows, as translated and released by the U.S. bishops:

Your Eminence,

Many bishops asked this Sacred Congregation about the force and significance of Canon 2335 of the Code of Canon Law which forbids Catholics under the pain of excommunication to join Masonic or other associations of the same kind.

During its long examination of this question, the Holy See frequently consulted interested episcopal conferences so it might be familiar with the nature of these associations and their present-day direction.

The great divergency of replies, however, reflecting the diverse situations of each nation, did not permit the Holy See to change the current general legislation, which therefore remains in force until the new canon law is published by the competent Pontifical Commission for the Code of Canon Law.

In considering particular cases it must be remembered that penal law is always subject to strict interpretation. Therefore, one may safely teach and apply the opinion of those authors who hold that Canon 2335 regards only those Catholics who join associations which plot against the Church.



In November 1974, the *Catholic Information Office* (the official press office of the Catholic Bishops of England and Wales) informed various news outlets of the change regarding Masonry, based on the same letter which Cardinal Šeper had sent to the English Catholic hierarchy.

The bishops also discussed the letter at their annual fall meeting and released a statement to explain how this would be applied in their country. In short, as they had previously described in their 1973 letter to the clergy, lay Catholics would be permitted to join the Masons with permission from their bishop. The official text from the English Hierarchy is as follows:

Canon 2335 of the Code of Canon Law forbade Catholics to join the Freemasons or any similar organization under pain of excommunication. The ban was imposed because in many countries Freemasonry was regarded as being a secret society plotting against Church and State. Times change.

The Holy See has reviewed the Church's present relationship with Freemasonry. Widespread consultations failed to produce a uniform response from the world's bishops, so the Sacred Congregation for the Doctrine of the Faith has recently told bishops that universal legislation is to remain unchanged, at least until the revision of the whole Code of Canon Law. But the congregation has ruled that Canon 2335 no

longer automatically bars a Catholic from membership of Masonic groups. In particular cases it is to be subject to the restrictive interpretation applied to penal legislation, so a Catholic who joins the Freemasons is excommunicated only if the policy and actions of the Freemasons in his area are known to be hostile to the Church.

Bishops of England and Wales have taken note of this guidance. They wish to clarify procedure in their countries until such time as the universal law of the Church is reformulated. A Catholic should regard himself first and foremost a member of the Catholic Church, finding his inspiration for Christian living in the Church and his fellowship within that community; but if he sincerely believes that membership of Freemasonry does not conflict with this deeper loyalty he should approach his bishop through his parish priest to discuss the implications of such membership. Local conditions would of course have to be kept in mind.

A Catholic who has in the past left the Church to become a Freemason is urged to seek reconciliation. Priests, religious and members of secular institutes are still forbidden by the universal law of the Church to accept membership of the masonic order or similar organizations.

After these announcements there was a period of adjustment as the Catholic world came to grips with this change. Diocesan newspapers regularly featured articles and editorials which reiterated the new teaching: while not encouraged, lay Catholics could now be permitted to join the Masons.

In October 1974, Bishop Walter Curtis of Bridgeport, Connecticut, released a statement in which he recommended that Catholics join the Knights of Columbus instead of the Masons despite the new permissibility. National columnist and notable Vatican II peritus Fr. John Sheerin wrote an editorial praising the change.

Anew look at Masons

The news of the latest Vatican pronouncement on the Fréemasons was long overdue. The Masonic bugstoe in recent years became a false alarm. In my youth I used to bear of three perils. Evidently, the cardinal's letter recognized the fact that today all Masons are not plotting against the Church or for the overthrow of governments. At one time that is precisely what Masons were doing in Catholic countries, and the Popes rightly condemned Masonry and excommunicated Catholics who embraced it. But times have changed. In 1971 Rev. Leo McFadden, then correspondent in Rome for the NC News Service, began an article: "Can a practicing Catholic join the Masons? Given the right conditions, the answer seems to be 'yes,' according to experts here (Rome)."

The experts were an Italian and a Spanish Jesuit — significant since both were from Latin nations in which Masons were once the great enemies of the Church. They argued that the ban against Masonry did not apply to those Masonic organizations where faith in a supreme being and the Bible were required and exclusion of any discussion in the lodge on arguments strictly political or religious and sincere respect for the law of the state were practiced.

In 1966, the Scandinavian bishops published a decision permitting Catholics to join Masonic lodges in their territory, for they found Masonry there to be unobjectionable. Before publishing the decision, the bishops submitted it to Rome. No Roman congregation criticized it.

The Catholic Church is ---

Many of Msgr. Bosler's comments are significant. He wrote "... the fact that today all Masons are not plotting against the Church (Catholic church) or for the overthrow of governments". This was clearly an admission that regular Freemasonry and Continental masonry are different in important ways. He also shares with his readers that "an Italian and a Spanish Jesuit" were instrumental in the decision, and that the "Catholic ban did not apply to those Masonic organizations where faith in a supreme being and Bible were required and exclusion of any discussion in the lodge on arguments strictly political or religious and sincere respect for the law or state were practice". Obviously that statement was reference to our regular Freemasonry.

Msgr. Bosler also informed his readers that preceding this period, in 1966, Scandinavian bishops, after investigating, starting permitting Catholics to join Freemasonry (The Swedish Rite of Freemasonry). Also, that the Swedish bishops had consulted with the Vatican and there was no objection voiced. Essentially, he said that the allowance for Catholics to join some forms of Freemasonry had been in effect since 1966!

In March 1976, Cardinal Terence Cooke of New York addressed the 31st annual Dedication Breakfast for New York State Freemasons. The *U.S. bishops' news ser*vice released coverage of what they called "a milestone in ecumenism" and it reminded readers that "in 1974 the Vatican's Doctrinal Congregation issued a letter saying that Catholics may join Masonic lodges that do not plot against the Church." Cooke told the Masons that the

"estrangement between the Church and the Masons in the past was partly due to a failure to communicate. Many of the problems of the modern world are due to such failures. In charity we must forgive such human error. Whatever happened in the past, it should not affect our future."

In 1978, Bishop Fulton Sheen wrote, "According to a letter sent to the presidents of the various National Conferences of Catholics Bishops by Cardinal Seper, membership by lay people in Masonic groups is acceptable, provided the groups are not actively hostile to the Church." The addition of the word "actively" is interesting, implying some element of actual proof is necessary before condemning a form of Freemasonry.

During this time, Catholics throughout the world were gradually coming to accept that things had changed, and Freemasonry was not necessarily bad or forbidden, according to the qualified permissions of the 1974 letter.

Then suddenly, and with little explanation, the hierarchy of the Catholic church stunningly reversed itself. In March of 1981, a strongly worded "clarification" was issued by the Vatican. Written by Cardinal Franjo Šeper. He said that the law of the Church forbidding all Catholics to participate in Masonry had not been changed by the 1974 letter. Warning against "erroneous and tendentious interpretations" of the 1974 letter, Šeper bluntly stated, "The present canonical discipline has not been modified in any way and remains in force. Therefore, neither excommunication nor the other penalties called for have been abrogated."

Just that quickly the old lies and fears about Freemasonry returned to official Catholic dogma. The reconciliation between Catholicism and regular Freemasonry was over. Cardinal Franjo Šeper claimed that it was all just a misunderstanding, that what was implied and later said outright said by high ranking Catholic officials was never correct. There was no explain why the supposed misunderstanding was allowed to go on for seven years, and be communicated around the world.

VATICAN CITY (RNS) — Saying that a 1974 ruling had been widely misinterpreted, the Vatican has reaffirmed its centuries-old ban on Catholic membership in the Freemasons.

A new statement by the Congregation for the Doctrine of the Faith, the Church's doctrinal watchdog, said there was no change in the Church law that bars Roman Catholics under penalty of excommunication from joining Masonic associations and other secret societies regarded as hostile to the Church.

The statement, signed by Cardinal Franjo Seper, prefect of the congregation, was offered as a clarification of "mistaken and tendentious interpretations" given to a 1974 letter written by Cardinal Seper

The letter, dated July 29, 1974.

Terence Cooke addressed 3,000 Masons in New York City, praising the U.S. branch of the movement for its charitable works, its "firm belief in a Supreme Being" and its patriotic role in American history.

The 1974 document said that Catholic laymen were free to join Masonic lodges "which do not plot against the Church." The letter also said that Catholic clergy religious and members of secular institutes (organizations for both clergy and laity who take vows but live in the world) were "still forbidden in every case to join any Masonic association."

An aide at the U.S. Catholic Conference in Washington, where advance copies of the new ruling had been sent, said the Vatican may have felt provoked to act in the

force. Therefore, neither excommunication nor the other penalties called for have been abrogated."

Regarding Cardinal Seper's letter of 1974, the statement says: "It refers to the interpretation that should be given to the canon in question (Canon 2335) and must be understood...only as a reminder of the general principles of interpretation of penal laws in the solution of cases of individual persons."

What this might mean was suggested by Cardinal Seper in his 1974 letter, which said: "In considering particular cases, it must be remembered that penal law is always subject to strict interpretation. Therefore, one may safely teach and apply the opinion of those authors who hold that Canon 2335 regards only those Catholics who join associations which plot against

This 1981 communication seemed to have caught almost everyone by surprise and it caused considerable confusion. Despite being framed as a reminder that nothing had ever changed, it stands in clear contradiction to the content of the 1974 letter. Even the U.S. bishops' news service, in its article announcing the supposed clarification, stated that Cardinal Seper had previously and explicitly given "qualified approval for Catholic laymen to join Masonic groups if circumstances allowed." Nevertheless, from March 1981 onward, the official line was once again that all Catholics were forbidden to participate in Freemasonry. It does not appear that any bishops' conference or any individual bishop or prominent Catholic leader ever publicly clarified what happened. In 1983, Cardinal Joseph Ratzinger, prefect of the Congregation for the Doctrine of the Faith (and later Pope), with the personal approval of Pope John Paul II,

issued a Declaration on Masonic Associations, which stated the Catholic church's objections to Freemasonry. The 1983 declaration states that "faithful who enroll in Masonic associations are in a state of grave sin and may not receive Holy Communion. Strangely, this came just after the 1983 update of canon law which removed all specific references to Masonry. The issue was addressed again in a 1985 letter, which made no mention of some previous objections to Masonry, yet introduced new objections.

We will never fully know what truly happened within the Vatican that re-energized a hostility to Freemasonry. However, we can look at what historically happened. Pope Paul VI died in August 1978. Pope John Paul I was elected and afterwards lived for only 33 days. Pope John Paul II was elected in October 1978, about 3 years prior to the Vatican's flip flop. The Vatican staff and leaders changed, and it appears that a more traditional group gained ascendency and was favored by the new Pope. It appears they brought back the old suspicions and hostility, and skewed perceptions. Additionally, during the period of almost reconciliation, some bishops in Germany, Austria and Italy were compiling reports containing some new objections to Freemasonry, based on the practices of Continental masons.


There was also rumors spread that the death of Pope John Paul I was a murder and resulted from a Masonic conspiracy. Some pundits even claimed that Freemasons had infiltrated the Vatican, and was the source of most of its problems. About this time the general public learned of the existence of a rogue organization known as P2, which had once been a legitimate Continental lodge until it lost its charter in 1976 for non-Masonic conduct and activities. After that it became a secret club for powerful and influential people. It was accused in the news media, by politicians and the Catholic church of all sorts of terrible things, and was represented to the public as an architype Masonic lodge. It was completely vilified as a criminal organization, although no charges were ever brought. All this fed the conspiracy theories. Even now, many years later, the current Pope has spoken of Masonic conspiracies in the Vatican and against the Catholic church.

The opportunity for reconciliation was lost, but perhaps not forever. I do see some signs that in the future there is the potential for rapprochement between regular Freemasonry and the Catholic church. However, at this time the foundation for reconciliation is not being laid by the hierarchy of the Catholic church, but instead at the lower levels. Change generally has the best chance of success if it starts at the lower levels of any organization. All around the world there are many Catholic Freemasons and more joining Freemasonry, thus demonstrating that individual Catholic men are recognizing the disconnect between the regular Freemasonry really is, and what their church claims it to be. Even some priests are actively or passively accepting Regular Freemasonry as a positive force, and thus no longer speak against it. Some priests have even actively engaged with Regular Freemasonry, although at some personal risk. Let us hope for improved relations in the future.

International Freemasonry

Freemasonry in East Africa

In most of the world there is at least one Grand Lodge per nation, or per state within a nation. However, in East Africa that is not the case. The District Grand Lodge of East Africa has lodges in the independent nations of Kenya, Uganda, Seychelles Islands, and Tanzania.



The Seychelles Islands have a population of nearly 93,000, Kenya over 53 million, Uganda nearly 46 million, and Tanzania nearly 64 million. In this huge area of about 163 million people there are at least 48 active Masonic lodges operating under the District Grand Lodge of East Africa, which itself operates under the authority of the United Grand Lodge of England.

This region, being on or near major ports on the Indian ocean has become home to a wide variety of people from the Arabian peninsula, Indian, and Europe. Starting in 1880 this region was part of the British Empire, and from status it absorbed many of its diverse peoples, cultures and practices. Today there are prosperous Christians, Muslims, Jews, Hindus and Sikh populations in these countries.

It is not known when the first Freemasons arrived in the region, or when they first started to meet informally. However, by the mid 1800's the port Zanzibar in present day Tanzania had many foreign residents. Freemasonry likely arrived there with the presence of British military forces because the military regiments often had their own Masonic lodges.

In the 1890s railroad construction started, and with it came more foreign engineers, technicians and workers. Informal Masonic lodges were functioning during this construction period, but most believe that the native African population was excluded during this time.

The first official and permanent Masonic lodge in East Africa was established in Zanzibar in 1904. In 1904, in what is now Kenya, a group of Freemasons petitioned the UK Grand Lodge concerning the formation of a Masonic Lodge in Nairobi. The Lodge Harmony was authorized and opened January 1905. The first Lodge in Uganda was Victoria Nyanza Lodge No 3492. It was opened in Entebbe in 1911. Tanzania was a German colony until the end of the first world war, so the first Lodge under the United Grand Lodge of England was not consecrated there until 1922. Its was named Haven of Peace Lodge No 4385. Over the years many more lodges were added. Also, there are currently four lodges in the Seychelles Islands.

Freemasonry in East Africa maintains informative websites and Facebook pages. However, I still found it somewhat difficult to obtain information about their planned activities. This could be because in some of this areas of this region, some of the local Christian churches (founded by 19th and 20th century by missionaries) have shown a rather remarkable hostility toward Freemasonry and individual Freemasons. In Kenya specifically, some church leaders have openly claimed that Freemasons are devils, evils spirits, snakes in the grass, and even the kidnappers of children. Such claims play upon the local superstitions, and have resulted in violent confrontations. Those churches' advocacy of hate have resulted in some Masonic

lodges being attacked, and public witch hunts for individuals who are Freemasons or just associating with Freemasons. The Freemasons have fought back with information campaigns and increased transparency, and as a result the situation has somewhat improved. We should keep in mind that these are still developing countries, where part of the population has limited access to education and unbiased information. Still, Freemasonry is strong and still growing in East Africa.


